4. Legal basis for Processing

Wherever the Processing of your data takes place in order to send you information by email, this shall occur on the basis of your expressly declared consent in accordance with Article 6, paragraph 1, letter a; Article 7; Article 4, no. 11 GDPR. Apart from this, Processing shall take place on the basis of Article 6, paragraph 1, letter f GDPR, wherein providing you with

customer service and, in the process, also contacting you about promotional matters constitute the legitimate interest necessary for said Processing on the part of Schuler AG and the other companies of the Schuler Group.

5. Recipients

The data are processed by employees in the Marketing, Sales, and Service departments of Schuler AG and the Schuler Group, who are responsible for providing your company with customer service, or for informing you or your company about new products or upcoming events.

7. Right to lodge a complaint with a supervisory authority

8. Withdrawal of consent, right to object
